# Guidelines For Certification of 'Private Candidates' under Craftsmen Training Scheme (w.e.f. 11.02.2019)

These guidelines are intended for 'Private Candidates' who have not received a formal institutionalized skill training under the CTS scheme, to directly enroll and appear for All India Trade Test (AITT) for award of National Trade Certificate (NTC).

#### 1. Background

The Directorate General of Training (DGT) imparts training under Craftsmen Training Scheme (CTS) through a network of 15000+ Government and Private ITIs across the country. These ITIs deliver post-school technical as well as vocational training courses of six months, one year and two year duration.

CTS, one of the major Vocational Training Schemes, has been shaping craftsmen to meet the existing as well as future manpower requirements in the manufacturing and service sectors. The trainees admitted under Government and Private Industrial Training Institutes (ITIs) (under State/UT Administration) undergo training in various designated trades/ courses. Candidates enrolled and trained under the CTS, appear for All India Trade Test (AITT). After successfully clearing AITT, the trainees are awarded National Trade Certificate (NTC) in that trade. The NTC is nationally and internationally recognized for purpose of employment/ self-employment.

#### 2. Objective

There is a large segment of country's workforce who has acquired specific skills through years of experience working on an industry trade, and not through formal institutionalized medium of skill training such as ITIs. However, this segment though skilled, faces issues related to continuous employment, and career progression due to non-availability of a 'formal certificate' acknowledging ones skills.

DGT has made provisions for such candidates to obtain National Trade Certificate (NTC) under the CTS by means of appearing directly for AITT as a 'Private Candidate' without undergoing training under ITIs. DGT has laid down specific guidelines for administering NTC to private candidates appearing for AITT under the CTS.

#### 3. Revision of existing guidelines

The guidelines for private candidates appearing in AITT under CTS were last revised on 8<sup>th</sup> February, 2016 vide DGT letter DGE&T-10/7(14)2014-16-CD (Refer *Annexure I*).

In the recently held Sub-committee meeting chaired by DG, DGT dated 18.10.2018, it was recommended and agreed upon that the existing guidelines for Private Candidates appearing in AITT under CTS should be reviewed and revised to improve inclusivity and effectiveness of the initiative. Subsequently, DGT has reviewed and revised the guidelines for 'Private Candidates' appearing in AITT under CTS only. The same, shall now be implemented in supersession to all the earlier existing guidelines, with immediate effect i.e. from academic session 2019 and onwards until further notices, if any. For 2018-19 academic session, the students already enrolled as

'Private Candidate' in DGT MIS Portal on or before 31.01.2019 will be frozen and no new candidates will be allowed. All new enrollments shall be done as per this revised guideline.

Further, it is to be noted that while drafting the revised guidelines, the recommendations of the "Curriculum & Examination Reforms Committee" on "Norms & Courses"; have been taken into consideration, in order to bring synergy between the two processes (Letter no. MSDE-18011/DGT/2017-TTC (Pt-III) dated 4<sup>th</sup>Oct. 2018) (Refer *Annexure II*).

Guidelines pertaining to eligibility of candidates, eligibility of participating ITIs, admission process and examination are elaborated in subsequent sections.

#### 4. Eligibility criteria for Trainee

Applicants aspiring to appear as Private Candidates in the AITT under CTS for award of NTC, have been categorized based on their educational background and experience. Subsequently 'Private Candidates' may be admitted under one of the following categories. Category wise 'eligibility criteria' for appearing as 'Private Candidate' in AITT under CTS has been listed below:

#### I. Category I: Ex-trainees (successful pass-outs) of ITI

- A. Ex-trainees of ITI who already possess NTC in one of the trades under CTS, are eligible for applying as Private candidate for an allied trade, provided he/ she fulfils all the conditions regarding educational qualification etc. prescribed for that allied trade. (Refer *Annexure III* for list of allied trades)
- B. In addition, the applicant should possess minimum of 1 year experience (as on date of submission of application) post the date of AITT result declaration in the desired allied trade in establishments implementing Apprenticeship Training Scheme (ATS)/ establishments registered under the Apprenticeship portal or registered MSMEs or Entities registered with any government/local authorities / shops covered under Factories Act 1948<sup>1</sup> and Shops and Establishments Act applicable for the concerned State.

#### II. Category II: 'Ex-trainees (successful pass-outs) and current trainees under CoE scheme

A. The applicant should have the minimum prescribed entry qualification and should fulfill eligibility criteria for the desired trade under CTS, in which he/she intends to appear for AITT as Private Candidate. Mapping of CoE trades, with that of regular CTS trades is provided in *Annexure IV*. CoE candidates must register as 'Private Candidate' under CTS in the relevant/mapped CTS trade only.

- B. There should be a minimum gap of 1 year between successful completion of CoE training i.e. from the date of result declaration to the date of submission of application for 'Private Candidate' certification.
- C. During this gap of 1 year, the candidate must have undergone Industry training or gained experience in desired trade in establishments implementing Apprenticeship Training Scheme (ATS)/ establishments registered under the Apprenticeship portal or registered MSMEs or Entities registered with any government/local authorities / shops covered under Factories Act 1948<sup>2</sup> and Shops and Establishments Act applicable for the concerned State.

#### III. Category III: SCVT Candidates (admitted till August 2018 session)

- A. No special provisions have been made for SCVT Trainees to enroll as 'Private Candidate'. Going forward, SCVT trainees have been granted equivalence vide G.S.R 186(E) dated 2nd March 2017 for undergoing apprenticeship training under the Apprentices Act 1961 to obtain 'NAC' (Refer *Annexure V*).
- B. Only for SCVT trainees admitted till August 2018 batch, provision has been made for obtaining NTC by appearing in AITT under 'Private Candidate'. Such trainees will continue to be governed by old guidelines for 'Private Candidate' (Refer *Annexure I*).

# IV. Category IV: Other Candidates (candidate not falling in any of the above 3 categories, including SCVT trainees enrolled from admission session 2019 onwards)

- A. The applicant should have the minimum prescribed entry qualification and should fulfill eligibility criteria for the relevant trade under CTS, in which he/she desires to appear for AITT as Private Candidate.
- B. Applicant should be minimum 21 years of age on the date of submission of application. There is no upper age limit.
- C. The applicant should possess minimum of 3 years' experience (on the date of submission of application) in the relevant trade in establishments implementing Apprenticeship Training Scheme (ATS)/ establishments registered under the Apprenticeship portal or registered MSMEs or Entities registered with any government/local authorities / shops covered under Factories Act 1948<sup>3</sup> and Shops and Establishments Act applicable for the concerned State.

D. SCVT trainees enrolled from admission session 2019 and onwards may appear as 'Private Candidate' under this category i.e. Category IV, for obtaining NTC.

# 5. Eligibility Criteria and instructions for ITIs admitting Private Candidates

- I. Only Government ITIs with grading of 2.0 and above are eligible to admit candidates as 'Private Candidate'.
- II. The ITI should have affiliation in the relevant trade under which it intends to admit Private Candidate for appearing in AITT.
- III. ITIs should have regular CTS trainees admitted in the affiliated trade i.e. the trade in which they intend to admit Private Candidate, for the current as well as previous year (ITI with vacant unit in current or previous batch shall not be considered).
- IV. The ITI can admit Private Candidates in a particular trade in specified proportion to the total number of regular trainees admitted in the concerned trade for the academic session.
- V. The upper limit of candidates to be enrolled by eligible ITIs as 'Private Candidate' under Category I, Category III and Category IV as defined in section 4 will be a maximum of 10% of their total seating capacity. The private candidates admitted under category II as defined in section 4 shall be exempted from the applicable 10% cap.

#### 6. Responsibilities of State Directorates

- I. State Directorates shall ensure that only ITIs fulfilling criteria as stated in section 5 of this document shall enroll Private Candidates.
- II. State Directorate shall publish list of eligible ITIs on their admission portal/ DGT MIS portal, with their corresponding grades and trades for awareness of 'Private Candidate' aspirants.
- III. State Directorates shall call for applications from candidates mentioning minimum qualification, experience and other eligibility criteria as per categories in section 4.
- IV. The State Directorates may conduct screening/ entrance exam of applicants if the number of applications/applicants is more than available seats (except for Category II, CoE scheme).
- V. State Directorate shall complete the enrollment of private candidates and freeze the list at least 3 months prior to the date of commencement of regular AITT examinations under CTS scheme for that academic session.

VI. State Directorate shall be responsible for all processes pertaining to admission of 'Private Candidates' including calling for application, screening/ entrance exam (if required), due-diligence of applications received, selection and uploading list of selected candidates on DGT MIS portal.

#### 7. Examination Pattern

All examinations for candidates enrolled as 'Private Candidate' shall be conducted in accordance with the latest examination reforms applicable to AITT for CTS (Ref. letter no. MSDE-18011/DGT/2017-TTC (Pt. III) issued on 4th Oct. 2018). Any future changes to AITT for CTS or examination reforms, as and when notified by DGT shall be applicable to Private Candidates as well.

- I. For trades with duration six months and one year, the candidate would appear as per the schedule of examination for that academic year. For trades with 2 years' duration, the candidate will have to clear all the subject examinations for that trade i.e. first year subject and second year subjects<sup>4</sup>.
- II. Candidate upon successfully clearing the AITT exams for targeted trade under CTS will be awarded e-Marksheet and e-National Trade Certificate as 'Private Candidates' in that trade.
- III. Evaluation and marking scheme: In the case of Private Candidates, since there is no sessional work or Formative Assessment, the marking scheme pattern for Engineering Trades shall be as follows<sup>5</sup>:

Standard Marksheet format for Non-Engineering and Draughtsman group of Trades and format for NTC are provided in *Annexure VI* and *Annexure VII*.

IV. Candidates permitted to take the AITT for CTS will have to be present at the specified examination center at their own expense in time and on the date as mentioned in their admit card/Hall ticket.

#### 8. Examination Fees

I. As actual or as decided by DGT plus any additional charges imposed by State Directorate.

#### 9. Frequency of Examinations

- I. The private candidate shall appear for first attempt in the AITT examinations along with regular candidates appearing under CTS for that academic session.
- II. Total number of attempts for private candidates shall be same as that of regular CTS trainee subject to payment of prescribed fees.
- III. Any changes to the total number of attempts, as per directives of DGT shall be applicable to 'Private Candidate' as well.

#### 10. Process flow

The process for certifying Private Candidates shall be as below:

#### I. <u>Call for Applications</u>

- A. The States shall call for applications from candidates with basic qualification, experience and other eligibility criteria, preferably online.
- B. States to make provisions for application submission process for private candidate applicants at least 6 months before the date of commencement of regular AITT examinations under CTS scheme for that academic session.

#### II. Application Process

The private candidate fulfilling the eligibility criteria may apply offline or directly in the State admission portal from where he/she desires to appear for exam irrespective of his/her native state, as per the concerned State's admission process. The sample format for application form for registration is attached as **Annexure VIII.** 

III. <u>Screening/ Entrance Examination (Optional):</u> State Directorate may screen the applications or conduct entrance test for eligible aspirants.

#### IV. <u>Due Diligence of Applications/Applicants</u>

- A. The State Directorate in-charge of training for CTS shall verify the authenticity of the particulars submitted by Private Candidates along with their application form such as ID proof, Photograph, Contact Number, e-Mail address, address proof, experience documents including salary slips/ bank statements, registration of establishment in Apprenticeship Portal etc., keeping in view the guidelines given above. After due diligence, the State Directorate shall approve the Private Candidate application in its system.
- B. State Directorate shall assign eligible ITIs to selected Private Candidates for appearing in AITT. States to provide complete name, address and contact details of ITI to the candidate.
- C. States shall upload details of all selected candidates on DGT MIS portal under the CTS scheme. The candidates will be assigned "Private" trainee flag under CTS scheme.
- V. The candidate would be assigned registration number as Private Candidate from DGT MIS portal.
- VI. The applicant shall be provided a system generated receipt acknowledging acceptance of admission.
- VII. The candidate shall deposit online examination fees plus any charges/ amount as decided by the State. Receipt of fee deposited shall be generated and provided to Candidate.
- VIII. Candidate shall then be provided online admit card, along with details of exams' schedule and theory and practical examination center.
  - IX. All other processes including uploading of mark sheet, e-certificate will be same as that of regular CTS candidates.

2. Directors dealing with Vocational Training of all States/ UT Administrations

Subject: Revised guidelines for candidates to appear for All India Trade Test (AITT) as a Private candidate under NCVT in semester system.

Sir.

NCVT has made provision for private candidates to appear for All India Trade Test for award of National Trade Certificate. The eligibility conditions for appearing in the AITT under CTS in respect of private candidates are as under:

- The applicant should have the minimum prescribed entry qualification for a particular trade under CTS in which he/she is desirous of appearing as private candidate.
- II. The applicant should possess minimum of 3 years' experience in the relevant trade in establishments implementing Apprenticeship Training Scheme/ small establishments covered under Factories Act, 1948 or Registered with any government/ local authorities.
- III. SCVT Certificate holder who has received institutional training in same trade with same duration of training period & entry qualification.
- IV. There should be trade test by SCVT for all the candidates who are desirous of appearing in the All India trade test under the aegis of NCVT as private candidates. All those, who qualify the SCVT test, may be permitted by the State Director to appear in the AITT under NCVT.
- V. Private candidates from establishments covered under the Apprentices Act, 1961 and sponsored candidates of ITIs and SCVT certificate holders (as in 3 above) may be exempted from appearing in the trade test to be conducted by the SCVT.
- VI. Apprentices under the Apprentices Act, 1961 who have failed six times in the All India Trade Tests for Apprenticeship can appear as private candidates in the corresponding ITI trade only. This will be only applicable to such apprentices who have not qualified earlier for the award of National Trade Certificate by the NCVT.

With operationalization of NCVT-MIS portal and to facilitate proper data entry on portal, the existing procedure for submitting the application by private candidates has been revised. The revised procedure is as under:

- a. The eligible private candidates having desired industry experience should apply to the State Director dealing with Craftsmen Training Scheme of any States irrespective of their native state, in the prescribed form,
  - Regular trainees of SCVT should apply to the State Director dealing with Craftsmen Training Scheme of the States where they are undergoing/ completed SCVT training
- b. Private candidates need to appear for all the semesters in that particular trade.
- c. SCVT trainees if desire to acquire National Trade Certificate as private candidates under NCVT then State Governments shall conduct training programme in semester system under SCVT and trainees after passing a particular semester exam in SCVT shall be allowed to appear in corresponding semester exam of AITT as private candidates under NCVT.
- d. The State Directors in-charge of training will verify the authenticity of the particulars of the private candidates keeping in view the guidelines given above before permitting them to appear in the AITT. State must have affiliated trade units in trades opted by candidates and candidates must be attached to an ITI having affiliated trade units in trades opted by candidates.
- e. The State Director (Secretary of the State Council) will submit a statement regarding the number of trainees in Engineering and non-Engineering trades ready to appear for the All India Trade Test in the prescribed proforma in triplicate to the Secretary, National Council of Vocational Training at least three months before the examinations are due to be held.
- f. Number of candidates do not depend upon affiliated trades units of ITIs.
- g. There is no upper age limit.
- Trainees after successfully passing all semester's exam for a trade shall be awarded National Trade Certificate as private candidates in that trade.

# Subject: Reforms in All India Trade Test conducted under the aegis of NCVT - regarding

Sir,

With reference to the recommendation of "Curriculum & Examination Reforms Committee" on examination system for exams conducted under the aegis of NCVT under Sub-Committee of National Council for Vocational Training (NCVT) on "Norms & Courses" the following reforms are hereby accepted for implementation in All India Trade Tests (AITT) conducted under aegis of NCVT.

- i) All the reforms here under will be applicable for the batch starting from the admission session August, 2018. However policy in respect of 'Grace Marks' for indicating (G) in marks sheet should be removed and may be implemented with immediate effect for all the schemes.
- ii) The DGT may go for On-line examinations for ITI trainees admitted for the session starting from August, 2018.
- iii) For the trainees admitted in ITIs from the session August, 2018 onwards & failed in theoretical papers should be granted grace marks up to the extent of maximum 06 (six) marks for each exams in one or more number of papers and there should not be any grace mark in practical examinations.

Also, the grace marks as above may be granted to the trainees in other schemes also i.e, DST, Flexi MoU & CoE under CTS, ATS and CITS, for examinations held after August, 2018.

However for trainees admitted under semester system before session August, 2018, the grace marks of 07 (Seven) for Engg trades and 02 (Two) for Non-Engg trades should continue as per prevailing guidelines till the sunset of semester

exams. These grace marks should not be indicated as 'G' in the marks card and grace marks provided in that paper may be added to marks secured by trainee to make it equal to pass marks and will result in increase of total marks obtained by trainee.

- (iv) For the trainees admitted in ITIs from the session August, 2018 onwards with NSQF complaint curriculum, the passing marks percentage in theoretical papers in Craftsmen Training Scheme is hereby reduced to 33% instead of existing 40%. However, passing marks percentage in practical examination will continue to remain as 60%. Accordingly, modified format of mark sheets for 1<sup>st</sup> and 2<sup>nd</sup> year of 01 year and 02 year courses in annexed. However, there is no provision of grace mark in practical examinations.
- (v) The NCVT has decided to provide graded autonomy to the Govt. and Private ITIs as per National Grading of ITIs in following cases:
  - a) All ITI's having infrastructure as per NCVT norms, may be self centre for practical exam with effect from AITT to be held in Jan/Feb19 in semester system and thereafter for annual exams also. However ITIs having grading less than 2.5 and also all ungraded ITIs, external examiner for practical examinations should be deputed by concern state/UT directorate.
  - b) All the ITI's having infrastructure as per NCVT norms and grade more than or equal to 2.5 may have their own examiner for practical examination in addition to self centre for practical exam. However, the examiner should be different from the instructor who has taught the trainees of the concern unit/shift during training.
  - c) All the ITIs providing training to Differently Abled (DA) trainees should have their self exam centre for theoretical paper exam as well as practical exam and may have their own examiner for practical examination.

In all the above cases, observers should be appointed by the state director for overall supervision of the exam.

Practical Examiner qualification: In addition to Degree/ Diploma and CITS passed out with 03 year experience in concerned discipline, the qualification for selection as practical examiner is hereby relaxed to ITI passed out instructors with atleast 03 (three) year of teaching experience.

- (vii A establishment engaging more than 100 apprentice at one premises may have their own practical examination centre for conducting the practical exam of their apprentices in AITT under ATS and evaluation may be done by their own examiner with own set of question paper. However, they should submit the marks obtained by apprentices to concerned RDAT/ SAA for processing and declaration of results. Such establishment should have all infrastructures in accordance with NCVT norms for practical examination.
- (viii) For early declaration of results of ITI trainees, the engineering drawing answer sheets of ITI trainees should be evaluated at every district nodal ITIs within three

- (03) working days from the last date of examination and marks of Practical & Engg Drawing should be uploaded in NCVTMIS portal by Nodal ITI.
- (ix) The annual exam for ITI trainees may be shifted to May/June in place of July/August for the trainees admitted from the session August, 2018 onwards. The supplementary exam may also be shifted accordingly in November/December each year.
  - (x) The examination duration of theoretical papers in objective MCQ type question paper examination in OMR based / online examination for trainees under CTS, CITS & ATS question paper having 50 to 75 MCQ type questions is hereby reduced to 02 hours in place of 03 hours, duration of question paper having 25 MCQ type question is reduced to 01.30 hours in place of 03 hours and the duration of Engg. Drawing paper is reduced to 03 hour in place of 04 hours. There is no change in duration of practical exam.
- (xi) There will be certification and issuance of National Craft Instructor Certificate (NCIC) as Recognition of Prior Learning to in-service instructors of ITI with 03 years of teaching experience in Private / Government ITI, the in-service instructors of Govt / Pvt ITI should be registered in any NSTI through CFI portal of NCVT as private candidates. They should appear in examination at NSTI for such purpose.

The self- learning content of one month training of pedagogy course will be made available on CSTRAI website and in-service instructors who are willing to appear for the said exam are advised to learn this before appearing in exam. The instructor of Govt ITI should be recommended from State Directorate and instructors of Private ITI should be recommended from Principal of concern institute.

Details of such instructors should be forwarded to any NSTI for registration of instructors in CFI portal as Private candidate. The Director NSTI should examine the recommendation and register the eligible candidate in CFI portal as private candidate.

The examination will be held in the concerned NSTI with question paper from DGT and the candidates will appear in the examination as private candidate. The examinations may be conducted in frequency of 02 to 03 months for the duration of 03 /04 days.

Initially this mode of certification will be offered for only 02 years i.e. up to Dec 2020. In future if required, the exam may be conducted in ITIs having grading of 3 or more.

The Registration / Examination fee of Rs.3000/- per candidate will be charged.

The examination paper for total - 500 marks should consists of -

- A. 1st Day Morning session Theory paper consisting of 03 parts = 150 marks
  - 1. Trade Theory 50 marks
  - 2. Workshop Science & Calculation 50 marks
  - 3. Training Methodology 50 marks
- B. 1st Day Afternoon session Engineering Drawing (50 marks)
- C. 2<sup>nd</sup> day Full day Training Methodology Practical Examination (100 marks) i.e.
  - i. Lesson plan development 20 marks
  - ii. Demonstration plan development 20 marks,
  - iii. Lesson plan delivery in class room 30 marks
  - iv. Demonstration activity in workshop/Lab 30 marks
- D. 3<sup>rd</sup> day Full day -Trade Practical Examination (200 marks) extended to next day if required.

The passing marks percentage will be 60% individually in every part of the examination.

You are requested to communicate all the stake holder for implementation of the above reforms in examinations conducted under aegis of National Council for Vocational Training 9NCVT) and necessary action in this regard.

G.S.R. 186(E).—In exercise of the powers conferred by sub-section (1) of section 37 of the Apprentices Act, 1961 (52 of 1961), the Central Government, after consulting the Central Apprenticeship Council, hereby makes the following rules further to amend the Apprenticeship Rules, 1992, namely:—

- 1. (1) These rules may be called the Apprenticeship (Second Amendment) Rules, 2017.
